WHEREAS, there is a critical need for all ordinances and resolutions to be submitted to the Van Buren County Clerk for placement on the Van Buren County Quorum Court's agenda to first be reviewed by the Van Buren County Deputy Prosecuting Attorney's Office.

THEREFORE BE IT ORDAINED AND ENACTED:

1. That all ordinances and resolutions shall be submitted to the Van Buren County deputy Prosecuting Attorney's Office for review before being submitted to the Van Buren County Clerk for placement on the Van Buren County Quorum Court's agenda; as a minimum ~~five~~ ^{ten} ₁₀ ~~(5)~~ work days prior to the regularly scheduled Quorum Court meeting date.
2. Other: This ordinance shall not encumber any Justice of the Peace from bringing any ordinance or resolution that he/she may deem necessary for the good of the county for action of the court ; so long as the requirements of Section 14-14-905 of the Arkansas Constitution Amendment 55, Act 742 of 1977, as amended are complied with.

NO. 100 BY THE AMOUNT OF \$2,710.09, AND INCREASE THE ANTICIPATED REVENUE FOR THE DETENTION CENTER BUDGET, DEPT. NO. 300 BY THE AMOUNT OF \$438.94, AND APPROPRIATE THE AMOUNT OF \$2,517.50 INTO THE VAN BUREN COUNTY SHERIFF'S OFFICE BUDGET DEPT. WHEREAS according to this year's audit, one employee of the Van Buren County Detention Center was overpaid from the year 2000 by \$407.75, and four employees of the Van Buren County Sheriff's Office were overpaid from the year 2000 by a total of \$2,517.50; and

WHEREAS because this pay came out of the 2001 budget, there is a critical need to appropriate \$2,517.50 into the Van Buren County Sheriff's Office budget, Dept. No. 100, Line Item No. 01 - Salaries, Full-time and \$192.59 into Line Item No. 06 - Social Security Matching, and appropriate \$407.75 into the Van Buren County Detention Center budget, Dept. No. 300, Line Item No. 01 - Salaries, Full-time and \$31.19 into Line Item No. 06 - Social Security Matching;

THEREFORE BE IT ORDAINED AND ENACTED:


