AN ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2001-52, THE ANNUAL OPERATING BUDGET FOR 2002, AND TRANSFER AND APPROPRIATE FROM THE COUNTY GENERAL FUND - 01 TO THE RECYCLING CENTER FUND - 03 DEPARTMENT BUDGET, #9600 THE SUM OF \$20,000.00.

WHEREAS, the County of Van Buren has continuously supported the Van Buren County Recycling Center ("Center") with financial appropriations and as of the beginning of 2002 has taken control of the fiscal responsibilities of the Center; and

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:

AN ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE NO. 2002-09, THE APPROPRIATION OF GRANT MONEY TO THE SHERIFF'S OFFICE FUND (#500), AND APPROPRIATE THE REVENUE OF THE DOMESTIC VIOLENCE GRANT TO THE NEW DOMESTIC VIOLENCE GRANT FUND (#44) IN THE SUM OF 115,500.00 FROM THE OFFICE OF INTERGOVERNMENTAL SERVICES.
