**Van Buren County Quorum Court**  
**Appropriation Ordinance Number 2002-19**

Be it enacted by the Quorum Court of the County of Van Buren, State Of Arkansas, an appropriation ordinance to be entitled:

**An appropriation ordinance to increase the anticipated revenue of the Sheriff's Office budget (#300) from County General to line item ~~#66~~<sup>#93</sup> Machinery and Equipment in the amount of \$11,111.71, for the purchase of a Cummins Diesel Generator for the Detention Facility.**

WHEREAS, there is a need and necessity that the above generator be purchased for the auxiliary power in the Detention Center.

WHEREAS, without auxiliary power the Detention Center lighting would not be possible in the event of a power failure, the loss of lighting would create a substantial risk to the lives and well being of both employees and detainees along with manufacturing a catastrophic security risk to the facility.

**Therefore be it ordained and enacted:**

1. That this ordinance increase the anticipated revenue to the Detention Center budget in the amount of \$11,111.71 as follows:

**Van Buren County Quorum Court  
Appropriation Ordinance Number 2002-20**

Be it enacted by the quorum court of the County Of Van Buren, State Of Arkansas, and Ordinance to be entitled:

**An Appropriation ordinance to amend ordinance number 2001-52, the annual operating budget for 2002, and transfer and appropriate the sum of \$33,530.00 from the county general to the Corps of Engineers fund #3900.**

WHEREAS: the Department Of Army Corp of Engineers has entered into a contract with the Van Buren County Sheriff's Office to pay said County the sum of \$33,530.00 for the purpose of providing funds for salaries and expenses incurred by the Van Buren County Sheriff's Office in patrolling the Federal Parks in said County; and

WHEREAS: there is a critical need and necessity for the appropriation of monies to pay incurred expenses to patrol the Federal Parks in said County;

**THEREFORE BE IT ORDAINED:**

Section 1. That ordinance number 2001-52, the annual operating budget for 2002 is hereby amended; and

Section 2. There is hereby appropriated and transferred the sum of \$33,530.00 from County General to the Sheriff's Office budget #3900 as follows:
