**AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2002-61, THE ANNUAL OPERATING BUDGET FOR 2003, AND INCREASE THE ANTICIPATED REVENUES TO THE COUNTY GENERAL FUND BY \$6,042.00 AND TRANSFER AND APPROPRIATE THE SUM OF \$6,713.00 FROM THE COUNTY GENERAL FUND 01 TO LAW ENFORCEMENT BLOCK GRANT FUND 33 DEPARTMENT 3001, LINE ITEM 87- MISCELLANEOUS.**

WHEREAS, the County of Van Buren has been awarded a grant under the Local Law Enforcement Block Grants Program in the amount of \$6,042.00;

WHEREAS, the County has agreed to provide \$671.00 in matching funds for this grant, and;

WHEREAS, the County has agreed to comply with the terms, representations, assurance and conditions of said grant;

**THEREFORE, BE IT ORDAINED:**

Section 1: That Appropriation Ordinance #2002-61 is hereby amended and the anticipated revenue for County General is increased by \$6,713.00;

Section 2: That there is hereby appropriated the sum of \$6,713.00 from County General to Law Enforcement Block Grant Fund 33 Department 3001, Line Item 87-Miscellaneous;

Section 3: That the Sheriff of Van Buren County, upon receipt of said grant monies, will, in compliance with the terms and conditions of the Law Enforcement Block Grant, deposit said grant monies into an interest bearing trust account and comply with all reporting requirements and all terms and conditions as set forth in the Special Conditions: Local Law Enforcement Block Grants Program;



BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AND ORDINANCE TO BE ENTITLED:

**AN ORDINANCE TO AMEND THE ORIGINAL ORDINANCE #2001-17, AN ORDINANCE PROHIBITING ALL ELECTED COUNTY OFFICIALS OF VAN BUREN COUNTY FROM EMPLOYING DEPUTIES AND COUNTY EMPLOYEES WHO ARE RELATED BY AFFINITY OR CONSANGUINITY WITHIN THE THIRD DEGREE TO ANY ELECTED COUNTY OFFICIAL; AND FOR OTHER PURPOSES. TO AMEND ORDINANCE #2001-17 TO READ AS FOLLOWS: AN ORDINANCE PROHIBITING ALL ELECTED COUNTY OFFICIALS OF VAN BUREN COUNTY FROM EMPLOYING DEPUTIES AND COUNTY EMPLOYEES WHO ARE RELATED BY AFFINITY OR CONSANGUINITY WITHIN THE FIRST DEGREE TO ANY ELECTED COUNTY OFFICIAL; AND FOR OTHER PURPOSES, AND TO AMEND PARAGRAPH 5 TO READ AS FOLLOWS: THAT ALL ELECTED COUNTY OFFICIALS IN VAN BUREN COUNTY ARE HEREBY PROHIBITED FROM EMPLOYING DEPUTIES OR COUNTY EMPLOYEES WHO ARE RELATED BY AFFINITY OR CONSANGUINITY WITHIN THE FIRST DEGREE TO ANY ELECTED COUNTY OFFICIAL.**

WHEREAS, Van Buren County Ordinance No. 2001-17 reads as follows: An ordinance prohibiting all elected county officials of Van Buren County from employing deputies and county employees who are related by affinity or consanguinity within the first degree to any elected county official: and for other purposes.

WHEREAS, paragraph 5 of ordinance #2001-17 reads as follows: That all elected County Officials in Van Buren County are hereby prohibited from employing Deputies or County Employees who are related by affinity or consanguinity within the third degree to any elected County Official.

THEREFORE, BE IT ORDAINED:

Section 1. That Ordinance Number 2001-17, is hereby amended; and

Section 2. That Ordinance No. 2001-17 shall read as follows: An ordinance prohibiting all elected county officials of Van Buren County from employing deputies and county employees who are related by affinity or consanguinity within the first degree to any elected county official: and for other.

Section 3. That Paragraph 5 of Ordinance #2001-17 is amended to read as follows: That all elected County Officials in Van Buren County are hereby prohibited from employing Deputies or County Employees who are related by affinity or consanguinity

within the first degree to any elected County Official.
