AN ORDINANCE APPROVING THE LEASE AGREEMENT TO BURNT RIDGE ENTERPRISES, LLC AND PRESCRIBING OTHER MATTERS RELATING THERETO.

WHEREAS, Van Buren County presently owns the real property adjacent to the property on which a new hospital facility (the "New Hospital") and nursing home facility (the "New Nursing Home") are being constructed; and

WHEREAS, Burnt Ridge Enterprises, LLC has committed to building a medical office building on certain property adjacent to the New Hospital and New Nursing Home which will enhance the delivery of quality healthcare services to the residents of Van Buren County, Arkansas; and

WHEREAS, the Quorum Court has determined that significant benefits will accrue to the citizens of Van Buren County from leasing certain of the adjacent property to Burnt Ridge Enterprises, LLC;

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS:

Article 1. The Ground Lease Agreement for that certain real property adjacent to the New Hospital and New Nursing Home as set forth therein between Van Buren County, as Lessor and Burnt Ridge Enterprises, LLC, as Lessee, attached hereto as Exhibit A, is hereby approved and the County Judge is authorized to execute and the County Clerk authorized to attest the execution of said Agreement.

Article 2. All ordinances and resolutions or parts thereof in conflict herewith are hereby repealed to the extent of such conflict.

Article 3. The County Clerk is hereby instructed to publish this Ordinance within seven days after its adoption and approval.
