BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN EMERGENCY ORDINANCE TO BE ENTITLED:

AN EMERGENCY ORDINANCE AMENDING EMERGENCY ORDINANCE NO. 2003-42, DECLARING AN EMERGENCY AND FOR OTHER PURPOSES

THEREFORE BE IT ORDAINED

- **1.** Section 1 Definitions of Emergency Ordinance No. 2003-42 is amended by adding:
- (B) Accompanied: In close enough proximity so that the hunting dog or stock dog is obedient to the owner or haborer(s) verbal commands to stay off of property which the owner or harborer(s) does not have permission to enter.
 - 2. Section 1 (E) of Emergency Ordinance No. 2003-42 is amended by adding the following:
- "(3) A hunting dog or stock dog is not considered an "animal-at-large" if it meets the restraint provisions of Section 1 (S) below."
 - **3.** Section 1 (S) of Emergency Ordinance No. 2003-42 is amended by adding the following:
- A. Insert the paragraph designation "(1)" in the beginning of the current provision, between the subsection title, "(S) Restraint:", and the sentence which follows said title.
 - B. Add the following language as subparagraphs "(2)" and "(3)":
- "(2) Hunting dogs, when accompanied by the owner on a hunt, are considered to be under reasonable restraint, and as long as the dog has affixed to it a collar with a hunting tag and a tag showing the owner's name, address, and phone number.
- "(3) Stock dogs used for herding livestock, when accompanied by the owner and being used in herding livestock, are considered to be under reasonable restraint, as long as the dog is affixed to it a collar with a tag showing the owner's name, address, and phone number."

4. Emergency Clause: Because of the large numbers of hunting and stock dogs in the county which might be considered as animals-at-large subject to impoundment under the present ordinance which provides no exemptions for dogs employed in hunting or herding, an emergency is hereby declared to exist and this ordinance being immediately necessary for the preservation of the public peace, health and safety, shall take effect and be in force from and after its adoption.
