



BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN EMERGENCY ORDINANCE ENTITLED:

AN EMERGENCY ORDINANCE TO AMEND ORDINANCE NO. 2003-5 AND ORDINANCE NO. 2001-17, AN ORDINANCE PROHIBITING ALL ELECTED COUNTY OFFICIALS OF VAN BUREN COUNTY FROM EMPLOYING DEPUTIES AND COUNTY EMPLOYEES WHO ARE RELATED BY AFFINITY OR CONSANGUINITY WITHIN THE FIRST DEGREE TO ANY ELECTED COUNTY OFFICIAL; TO PROVIDE A PROCEDURE FOR THE QUORUM COURT OF VAN BUREN COUNTY TO GRANT EXCEPTIONS TO HIGHLY QUALIFIED INDIVIDUALS WHO WOULD OTHERWISE BE PROHIBITED FROM BEING HIRED DUE TO THE AFOREMENTIONED ANTI-NEPOTISM ORDINANCE; AND FOR OTHER PURPOSES.

THEREFORE BE IT ORDAINED AND ENACTED:

Section 1. That Ordinance Number 2001-17 and Ordinance No. 2003-5, is hereby amended; and

Section 2. That the Quorum Court of Van Buren County may by majority vote at any regular or special meeting grant an exception to the County Anti-Nepotism Ordinance to hire a person found to be a highly qualified individual due to special training or experience who after considering all other applicants would be found to be the most qualified person who would be an asset to the County Department. Under no circumstances may the exception be granted to allow the person to work for a relative in the first degree of consanguinity or affinity but may work in another department of County Government.

Section 3. This Ordinance being necessary for the preservation of the public peace, health, safety and welfare, it is therefore declared that an emergency exists because a highly qualified person who is related in the first degree of consanguinity or affinity to a different elected county official has applied for a position in the Sheriff's Office which needs to be filled in order to conduct business in an efficient manner. That this Ordinance shall be in full force and effect from and after its passage.
