STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:

AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL
APPROPRIATION ORDINANCE #2003-74, THE ANNUAL OPERATING
BUDGET FOR 2004; TO INCREASE THE PROJECTED REVENUE FOR THE
RECYCLING CENTER BY \$6,200.00; AND INCREASE THE ANTICIPATED
REVENUE FOR THE TRANSFER STATION BY \$67,000.00; AND
APPROPRIATE \$73,200.00 INTO THE SOLID WASTE MANAGEMENT FUND
