BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:

AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2003-74, THE ANNUAL OPERATING BUDGET FOR 2004, TO INCREASE THE PROJECTED REVENUE FOR THE VAN BUREN COUNTY JUDGE'S BUDGET FUND #01, DEPT 100; BY TRANSFERRING \$448.00 FROM THE VAN BUREN COUNTY GENERAL FUND #01 AND APPROPRIATING SAID AMOUNT TO THE VAN BUREN COUNTY JUDGE'S BUDGET FUND #01, DEPT 100, LINE ITEM 87 – OTHER MISCELLANEOUS.

WHEREAS: There is scheduled a Grant Proposal Writing Workshop at the University of Arkansas at Little Rock, November 1 – 3, 2004; and

WHEREAS: Christina Lang has requested that she attend this workshop, in order to write grants for Van Buren County and the City of Fairfield Bay; and

WHEREAS: Van Buren County will pay \$448.00 (one-half of the \$896.00; \$597.00 for tuition plus \$299.00 for expenses) with the City of Fairfield Bay paying one-half.

THEREFORE, BE IT ORDAINED:

Section 1. That Ordinance No. 2003-74, the annual operating budget for 2004 is hereby amended; and

Section 2. That the sum of \$448.00 is hereby transferred from the Van Buren County General Fund #01; and

Section 3. That the sum of \$448.00 is hereby appropriated to the Van Buren County Judge's Budget Fund #01, Department 100, Line item 87 - Other Miscellaneous

AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2003-74, THE ANNUAL OPERATING BUDGET FOR 2004, TO INCREASE THE PROJECTED REVENUE BY \$4,000.00; AND TO APPROPRIATE SAID AMOUNT TO THE VAN BUREN COUNTY FAIR ASSOCIATION GRANT FUND #91; DEPARTMENT 1008; LINE ITEM #86 – SPECIAL PROJECTS.

WHEREAS: The Arkansas Rural Development Commission has awarded the Van Buren County Fair Association a Grant in the amount of \$4,000.00; and
