AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2003-74, THE ANNUAL OPERATING BUDGET FOR 2004, TO INCREASE THE PROJECTED REVENUE FOR THE VAN BUREN COUNTY ANIMAL CONTROL BUDGET FUND #23, DEPT 2005, BY TRANSFERRING \$4,500.00 FROM THE VAN BUREN COUNTY ANIMAL CONTROL FUND #23 AND APPROPRIATING SAID AMOUNT TO THE ANIMAL CONTROL BUDGET FUND #23, DEPT 2005.

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:

AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2003-74, THE ANNUAL OPERATING BUDGET FOR 2004, TO INCREASE THE PROJECTED REVENUE OF THE SOLID WASTE MANAGEMENT BUDGET FUND #28 BY THE SUM OF \$109,958.17, BY TRASFERRING \$55,000.00 FROM THE SOLID WASTE MANAGEMENT FUND #28; AND BY TRANSFERRING \$54,958.17 FROM VAN BUREN COUNTY GENERAL FUND; AND APPROPRIATING SAID AMOUNTS INTO THE SOLID WASTE MANAGEMENT BUDGET FUND #28, DEPARTMENT 3300.

WHEREAS: There is a critical need to appropriate additional funds that have been collected in 2004 to be used for the operation of the Van Buren County Solid Waste Management, and

WHEREAS: There is a critical need for additional monies to be transferred from the General Fund to increase the projected revenue.

THEREFORE BE IT ORDAINED AND ENACTED

Section 1. That Ordinance No. 2003-74, the annual operating budget for 2004 is hereby amended; and

Section 2. That the sum of \$55,000.00 is hereby transferred from the Solid Waste Management Fund 28 and appropriated into the Solid Waste Management Budget Fund 28, Department 3300; and

Section 3. That the sum of \$54,958.17 is hereby transferred from Van Buren County General Fund #01 and appropriated into the Solid Waste Management Budget Fund 28, Department 3300, as follows:
