WHEREAS, it is the desire of the Quorum Court to change the regular meeting time to 7:00 P.M.


THEREFORE, BE IT ORDAINED:

WHEREAS; There is a need for funds to renovate the old hospital building to be used for County offices.

THEREFORE, BE IT ORDAINED:

Section 1. That Ordinance No. 2004-54, the annual operating budget for 2005 is hereby amended; and

Section 2. That the sum of \$200,000.00 is hereby transferred from the Van Buren County General Fund #01; to the Van Buren County Road Fund, #02, (to be appropriated at a later date).

Section 3. That the sum of \$35,000.00 is hereby transferred and appropriated to the Van Buren County Senior Citizens Budget Fund #01, Department 4304, Line Item 81.

Section 4. That the sum of \$25,100.00 is hereby transferred to the Van Buren County Courthouse Improvement Fund #9, (to be appropriated at a later date).

Section 5. That the sum \$28,900.00 will remain as the 10% reserve.


