WHEREAS: There is a need and necessity to increase the donation requested for interim maintenance of unwanted animals until the animal is adopted or destroyed as deemed proper; and

WHEREAS: There is a need and necessity to increase the fee to adopt an animal.

1. Section 8; Relinquishment of unwanted animals is amended by increasing the interim maintenance fee to \$20.00 per animal.
2. Section 9: Adoption: (A) (1) is amended as follows: Payment of an adoption fee of \$35.00 per each canine and \$25.00 per each feline and any vaccination, licensing if applicable, or veterinary costs
3. Emergency Clause: Because of the immediate need to increase these fees, an emergency is hereby declared to exist and this ordinance being necessary for the preservation of the public peace, health and safety, shall take effect and be in force from and after its adoption.




