The goal of this project is to make Van Buren County's recycling operation more efficient, and to increase the recycling volume. To do this, they plan to purchase the following:

- a. A plastic perforator with a conveyor to the baler. The perforator will enable the existing baler to make heavier bales by perforating and flattening bottles as they are fed into the baler, increasing bale density and reducing storage space. It will also facilitate the sorting of plastics and transfer into the baling machines, resulting in a savings of material handling and manpower costs. Cost is \$9,400.00
- b. Twelve each 6' x 8' trailers for cardboard. The trailers will result in significant time and manpower savings by allowing route drivers to easily pick up a full trailer and drop-off an empty one, eliminating the need to hand load cardboard on the pick-up route. The trailers will be used at businesses and institutions that generate large amounts of cardboard. Cost is \$12,000.00
- c. Recycling bins, boxes and bags will be used for receiving, handling, sorting and storing materials at the recycling center. Cost is \$5,000.00
- d. Equipment maintenance and operation costs will include repairs, replacement parts and labor, baler wire, and other equipment maintenance costs. Cost is \$9,340.00

**Section 3:** That the sum of \$25,000.00 is hereby transferred from the Van Buren County Solid Waste Management Fund #28 and appropriated into the Van Buren County Solid Waste Management Budget Fund #28, Department 3300, Line Item 93 – Purchases: Machinery and Equipment.
