

ORDINANCE NO. 2009-7

**BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN,
STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:**

**AN ORDINANCE AUTHORIZING THE LEVY OF AN ADDITIONAL
TWENTY DOLLAR (\$20.00) FINE TO HELP DEFRAY THE EXPENSE
OF INCARCERATING PRISONERS IN THE VAN BUREN COUNTY
JAIL; PURSUANT TO ACT 209 OF 2009; TO DECLARE AN
EMERGENCY AND FOR OTHER PURPOSES**

WHEREAS: On July '17, 2003, the Van Buren County Quorum Court passed and enacted County Ordinance 2003-43 that levied, under authority of Act 1188 of 2003, an additional five dollar (\$5.00) fine on each case brought before the District Court to help defray the expenses of incarcerating prisoners in the County Jail; and

WHEREAS: The Arkansas General Assembly has now passed Act 209 of 2009, which authorizes the County by Ordinance, to levy an additional twenty dollar (\$20.00) fine to help defray the expense of incarcerating prisoners in the County Jail. This additional fine would replace the existing five dollar (\$5.00) fine currently levied under County Ordinance No. 2003-43; and

WHEREAS: Since Van Buren County operates a County Jail, the additional fines to be levied by this Ordinance under authority of Act 209 of 2009 shall be deposited into a special fund, the Jail Maintenance Fund, within the County Treasury to be used exclusively to help defray the cost of maintenance, operation and capital expenditures of the County Jail or as otherwise permitted under Act 209 of 2009; (see attachment) and

WHEREAS: The Arkansas General Assembly provided that it is the intent of Act 209 of 2009 that revenues derived from the additional fines levied under authority of said Act shall not offset or reduce funding from other sources for the maintenance, operation, and capital expenditures of the Detention facilities; and

WHEREAS: It is in the best interests and welfare of the citizens of Van Buren County, Arkansas that an additional fine of twenty dollars (\$20.00) be levied and collected from each defendant who pleads guilty or nolo contendere to, is found guilty of or forfeits bond for any misdemeanor or violation in the District Court of Van Buren County Arkansas and the individual departments thereof.

**NOW, THEREFORE BE IT ORDAINED AND ENACTED BY THE QUORUM COURT
OF VAN BUREN COUNTY, ARKANSAS:**

SECTION 1: Under authority of Act 209 of 2009, there is hereby levied and shall be collected an additional fine in the amount of twenty dollars (\$20.00) from each defendant upon each conviction, each plea of guilty or nolo contendere or each bond forfeiture in all cases in the first and second class of accounting records as described in A.C.A. 16-17-707. The additional fine shall apply to each charge, count, violation, or offense that a defendant pleads guilty or nolo contendere to, if found guilty of, or forfeits bond for, including each misdemeanor or violation.

SECTION 2: The additional fine levied in Section 1 hereinabove shall apply to all applicable cases brought before all District Courts and departments thereof that now exist and are in operation, or may hereafter be created and placed into operation, within Van Buren County.


SECTION 3: All additional fines levied and collected under the provisions of this Ordinance shall be deposited into a special fund within the County Treasury to be used for the maintenance, operation, and capital expenditures of the County Jail or as otherwise specifically permitted under the provisions of Act 209 of 2009.

SECTION 4: All ordinances or parts of ordinances found to be in conflict herewith including specifically County Ordinance No. 2003-43 in its entirety, are hereby repealed.

SECTION 5: EMERGENCY CLAUSE: It is found and determined by the General Assembly of the State of Arkansas that the increasing costs of incarcerating or otherwise keeping prisoners in county jails creates an economic hardship; that maximum fines allowed by statute for convicted persons are too low; and that this act is immediately necessary because county jails are overcrowded. Therefore, an emergency is declared to exist, and this act being immediately necessary for the preservation of the public peace, health, and safety shall become effective on July 1, 2009.

**AN ORDINANCE TO AUTHORIZE AN ANALYSIS OF THE
FEASIBILITY OF CREATING A SEPARATE OFFICE OF VAN BUREN
COUNTY CLERK; TO APPROPRIATE FUNDS FOR PURCHASING THE
ANALYSIS SERVICES FROM A PUBLIC OR PRIVATE VENDOR; TO
PROVIDE FOR THE FINAL DATE OF COLLECTION OF SUCH
ANALYSIS; AND FOR OTHER PURPOSES.**

ARTICLE 1. There is hereby authorized an analysis of the feasibility of creating a separate office of Van Buren County Clerk pursuant to A.C.A. 14-14-605. This analysis shall include an inventory of the present duties performed by the combined office of Van Buren County Circuit Clerk and Van Buren County Clerk, estimates of the cost of operating a separate office of County Clerk and an examination of the benefits to be derived in terms of relative costs and increased efficiency.


ARTICLE 2. An appropriation in the amount of \$1,500.00 is hereby made from the Van Buren County General Fund for the purpose of purchasing analysis services from a private or public vendor.

ARTICLE 3. The final date of completion of the aforementioned analysis shall be not later than September 1, 2010.

ARTICLE 4. It is hereby declared and determined by the Van Buren County Quorum Court that the public interest requires an immediate examination of the duties and work load in the office of the Van Buren County Circuit Clerk and Van Buren County Clerk. Therefore, an emergency is hereby declared to exist and this ordinance being necessary for the immediate preservation of public property and affairs shall be in full force and effect from and after its passage.

ORDINANCE NO. 2009- 10

AN ORDINANCE OF VAN BUREN COUNTY, ARKANSAS TO PROHIBIT THE HOSTING OR PERMITTING GATHERINGS WHERE MINORS CONSUME ALCOHOLIC BEVERAGES; PROVIDING FOR THE IMPOSITION OF FINES AND COSTS AGAINST THE PERSON OR PERSONS HAVING CONTROL OF THE PREMISES; PROVIDING FOR REPEAL OF ORDINANCES INCONSISTENT HERewith AND ALLOWING FOR SEVERABILITY.

BE IT ORDAINED BY VAN BUREN COUNTY, ARKANSAS:

SECTION 1:

Allowing Gatherings Where Minors are Consuming Alcoholic Beverages.

(A) Definitions. For purposes of this section, the following definitions shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

“ALCOHOL” means ethyl alcohol, hydrated oxide of ethyl, or spirits or wine, from whatever source, or by whatever process produced.

“ALCOHOLIC BEVERAGE” includes alcohol, spirits, liquor, wine, beer, and every liquid or solid containing alcohol, spirits, wine, or beer, and which contains one-half of one (1) percent or more of alcohol by volume and which is fit for beverage purposes either alone or when diluted, mixed, or combined with other substances. This term includes intoxicating beverages and low point beer as defined herein.

“GATHERING” is a party, gathering, or event, where a group of three or more minors have assembled or are assembling for a social occasion or social activity.

“INTOXICATING BEVERAGE” includes beverages containing more than three and two-tenths percent (3.2%) alcohol by weight.

“LEGAL GUARDIAN” means (1) a person who, by court order, is the guardian of the person of a minor; or (2) a public or private agency with whom a minor has been placed by the court.

“LOW POINT BEER” means and includes beverages containing more than one-half of one percent ($\frac{1}{2}$ of 1%) alcohol by volume, and not more than three and two-tenths percent (3.2%) alcohol by weight, including by not limited to beer or cereal malt beverages obtained by the alcoholic fermentation of an infusion of barley or other grain, malt or similar products.

“MINOR” means any person under twenty-one (21) years of age.

“JUVENILE” means any person less than 18 years of age except where otherwise specified under the section. The term “JUVENILE” is synonymous with the term “MINOR” as provided in the section.

“PARENT” means a person who is a natural parent, adoptive parent, foster parent, or stepparent of another person.

“PREMISES” means any residence or other private property, place, or premises, including any commercial or business premises.

“RESPONSE COST” are the costs associated with responses by law enforcement, fire, and other emergency response providers to a gathering, including by not limited to: (1) salaries and benefits of law enforcement, code enforcement, fire, or other emergency response personnel for the amount of time spent responding to, remaining at, or otherwise dealing with a gathering, and the administrative costs attributable to such response(s); (2) the cost of any medical treatment for any law enforcement, code enforcement, fire, or other emergency response personnel injured responding to, remaining at or leaving the scene of a gathering; (3) the cost of repairing any County equipment or property damaged, and the cost of the use of any such equipment, in responding to, remaining at, or leaving the scene of a gathering; and (4) any other allowable costs related to the enforcement of this Section.

“YEAR OF AGE” continues from one birthday, such as the 17th, to, but not including, the day of the next, such as the 18th or the 21st birthday.

(B) Consumption of Alcohol by Minor In Public Places, Place Open to Public, or Place Not Open to Public.

Except as permitted by state law, it is unlawful for any minors to:

- (1) consume at any public place or any place open to the public alcoholic beverage; or
- (2) consume at any place not open to the public any alcoholic beverage, unless in connection with the consumption of the alcoholic beverage that minor is being supervised by his or her parent or legal guardian.
- (3) Host, Permit, or Allow a Party, Gathering, or Event Where Minors Consuming Alcoholic Beverages is occurring.

(C) PROSCRIBED CONDUCT.

- (1) It is the duty of any person having control of any premises, who knowingly hosts, permits, or allows a gathering at said premises to take all reasonable steps to prevent the consumption of alcoholic beverages by any minor at the gathering. Reasonable steps are controlling access to alcoholic beverages at the gathering; controlling the quantity of alcoholic beverages present at the gathering; verifying the age of persons attending the gathering by inspecting driver's licenses or other government-issued

identification cards to ensure that minors do not consume alcoholic beverages while at the gathering.

- (2) It is unlawful for any person having control of any premises to knowingly host, permit, or allow a gathering to take place at said premises where at least one minor consumes an alcoholic beverage, whenever the person having control of the premises either knows a minor has consumed an alcoholic beverage or reasonably should have known that a minor consumed an alcoholic beverage had the person taken all reasonable steps to prevent the consumption of an alcoholic beverage by a minor as set forth in subsection (C)(1) of this Section.
- (3) This Section shall not apply to conduct involving the use of alcoholic beverages that occurs exclusively between a minor and his or her parent or legal guardian.
- (4) Nothing in this Section should be interpreted to prohibit any family activity held in the confines of the family home from providing the use of alcohol to immediate family members within the supervision of parents and guardians. However, if a minor leaves such a family gathering intoxicated and is found in public then said providers of alcohol will be held responsible in the same manner as a non-family gathering.
- (5) Nothing in this section should be interpreted to prohibit any religious practice which includes the use of alcohol. However, if a minor leaves such a religious gathering intoxicated and is found to be in public then said providers of alcohol will be held responsible in the same manner as a non-religious gathering.
- (6) This Section shall not apply to any premises licensed by the State of Arkansas to dispense alcoholic beverages.

(D) CRIMINAL PENALTIES AND CIVIL REMEDIES.

- (1) Any person who shall violate the provisions of this Section shall be deemed guilty of an offense against the County and upon conviction thereof shall be punished for violation of an unclassified misdemeanor first offense, with a fine of Five Hundred Dollars (\$500.00) plus all court costs and statutory penalties, as set forth in this Ordinance and with a fine of One Thousand Dollars (\$1000.00) for a second or subsequent offense, plus all court costs and statutory penalties.
- (2) Any juvenile who shall violate the provisions of this Section shall be deemed guilty of an offense against the County and upon conviction thereof shall be punished for violation in the Van Buren County Juvenile Court.
- (3) Violations of this Section shall be prosecuted by the Prosecution Attorney of the 20th Judicial District criminally, civilly, and/or administratively as provided by this Ordinance. The County may seek administrative fees and response costs associated with enforcement of this Section through all remedies or procedures provided by statute, ordinance, or law. This Section shall not limit the authority of peace officers or private citizens to make arrests for any criminal offense arising out the conduct regulated by this section, nor shall they limit Counties ability to initiate and prosecute any criminal offense arising out of the same circumstances necessitating the application of this Section.

(E) LOCAL AUTHORITY.

This Section shall not apply where prohibited or preempted by state or federal law.


SECTION II:

That this section shall repeal all Ordinances or section of Ordinances that are inconsistent herewith.






