EMERGENCY ORDINANCE NO. 2011-3

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN,
STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN EMERGENCY ORDINANCE APPROVING THE CREATION OF
TWO (2) NEW POSITIONS AT THE VAN BUREN COUNTY
DETENTION CENTER, IN ORDER TO BE IN COMPLIANCE WITH
STATE JAIL STANDARDS.

WHEREAS: The State Jail Inspection report, from last November, made a
recommendation that our staff at the Van Buren County Detention Center should have at
least three jailors on duty at all for each shift; and

WHEREAS: In order to bring the County Jail into compliance with this recommendation,
there is a need and necessity to create two new positions.

THEREFORE BE IT ORDAINED:

That the Van Buren County Quorum Court hereby approves that the staff for the County
Detention Center be increased by two additional employees. And upon approval of this
ordinance, funds for personal services of these two positions be approved for 2011 as
presented by the attached transfer.

Emergency Clause; This Ordinance being necessary for the preservation of the public
peace, health, safety and welfare, it is therefore declared that an emergency exists and this
Ordinance shall be in full force and effect from and after its passage.
