BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN,
STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL
APPROPRIATION ORDINANCE 2010-20, THE ANNUAL OPERATING
BUDGET FOR 2011, TO INCREASE THE PROJECTED REVENUE BY
\$3,500.00 AND APPROPRIATE SAID AMOUNT INTO THE EDWARD
BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT (JAG) PROGRAM

WHEREAS: The Department of Finance and Administration Office of Intergovernmental Service has approved Van Buren County to receive a Special Purpose Mini Grant from the Edward Byrne Memorial Justice Assistance Grant (JAG) Program. WHEREAS: The County has received the \$3,500.00 and there is a need and necessity to appropriate these funds.


THEREFORE BE IT ORDAINED:
