

VAN BUREN COUNTY QUORUM COURT

ORDINANCE NO. 2012-2

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED AN ORDINANCE LEVYING AND APPROVING THE COLLECTION FOR THE YEAR 2012 THE VARIOUS PROPERTY TAXES HERETOFORE IMPOSED IN VAN BUREN COUNTY; REPLACING REPEALED ORDINANCE 2011-43 AND ORDINANCE 2011-52.

WHEREAS: the people of Van Buren County have approved the following property taxes, and;

WHEREAS: in accordance with Act 14-14-904 (b)(1) the Van Buren County Quorum Court shall levy the property taxes for county, municipal and school taxes for the following year (as corrected).

IN THE MATTER OF CHANGING THE MILLAGE LEVY TO COMPLY WITH THE ARKANSAS CONSTITUTION.

After having been apprised of all the facts and circumstances associated with the incorrect millage levy as it applies to the Southside School District and the Shirley School District, this Court finds and Orders the following:

1. The Van Buren County Clerk before the November Quorum Court meeting was provided the millage levy for all taxing entities. County Ordinance 2011-43 was approved on November 17, 2011.
2. Before the December Quorum Court meeting the Van Buren County Clerk received word the Clinton (both real and personal) had changed due to assessment inconsistencies. Clinton's millage levy changed from 36.5 to 36.6 by an amending Ordinance 2011-52.
3. Before the January Quorum Court meeting the Van Buren County Clerk received word that due to more assessment inconsistencies several of the taxing units tax levy had been changed again. These were: Clinton from 36.5 to 36.8; Southside - 37.0 to 38.4 and Shirley - 35.7 to 35.47.
4. With these changes the Van Buren County Quorum Court repealed Ordinance 2011-43 and on January 19, 2012 the Quorum Court approved Ordinance 2012-2 with these changes.
5. According to correspondence received in January, after the January meeting, the millage levy for Southside School District and Shirley School District was again deemed to be incorrect.
6. Further, the County Court hereby directs the Van Buren County Clerk to correct the errors in order to correct the millage levy.

Wherefore, the Van Buren County Court hereby orders the Van Buren County Clerk to adjust and correct the Southside School District and the Shirley School District millage levy as follows:

Southside School District from 38.4 to 38.6 (both real and personal)
Shirley School District from 35.47 to 35.5 (both real and personal)
