ORDINANCE NO. 2012-8

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:

AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2011-50, THE ANNUAL OPERATING BUDGET FOR 2012, TO RAISE THE PROJECTED REVENUE BY \$42,371.30; AND APPROPRIATE SAID FUNDS INTO THE FEMA #1975-FUND NO. 3400.

WHEREAS: These funds were receipted into the FEMA #1975 – Fund #3400; and

WHEREAS: These are unrestricted funds which belong to the County Road Department; and

WHEREAS: In order to carry out Court Order No. 2012-13 and transfer these funds to the County Road Department, the funds must be appropriated into FEMA Fund #1975 – Fund No. 3400.

THEREFORE, BE IT ORDAINED:

Section 1. That the Annual Operating Budget for the year 2012 is hereby amended; and

Section 2. That \$42,371.30 is hereby appropriated into the FEMA #1975 – Fund No. 3400.


COURT ORDER 2012-13
