BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN,
STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:

AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL
APPROPRIATION ORDINANCE #2011-50, THE ANNUAL OPERATING
BUDGET FOR 2012, TO INCREASE THE PROJECTED REVENUE BY
\$871,966.00 AND TO APPROPRIATE SAID AMOUNT INTO THE LINN
CREEK/WHISTLE STOP ROADS PROJECT BUDGET FUND #2901.

WHEREAS: Van Buren County has received a grant in the amount of \$871,966.00 for the reconstruction and resurfacing of approximately four (4) miles of the afore mentioned County Roads that were damaged by flood waters in the year 2008; and

WHEREAS: There is now an urgent need and necessity to appropriate these funds, in order to begin the work on this project.

THEREFORE BE IT ORDAINED

Section 1. That Ordinance No. 2011-50, the annual operating budget for 2012 is hereby amended; and

Section 2. That the sum of \$871,966.00 is hereby appropriated into the Linn Creek/Whistle Stop Roads Project Budget Fund #2901.
