ORDINANCE NO. 2013-04

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:

AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2012-18, THE ANNUAL OPERATING BUDGET FOR 2013, IN ORDER TO INCREASE THE ANTICIPATED REVENUE AND APPROPRIATE \$49,457.66 (2010 FUNDS) INTO THE (SHSGP) HOMELAND SECURITY GRANT BUDGET.

WHEREAS: Van Buren County OEM has filed a Competitive Application Proposal in anticipation of receiving the aforementioned funds; and

WHEREAS: This amount is based on a quote received February 7, 2013 which is firm for a 30-day period, in order to make the purchase within this time frame (should we receive the requested amount) the funds need to be appropriated at this meeting February 21, 2013. The funds have to be spent before receiving the grant amount.

THEREFORE, BE IT ORDAINED:

Section 1. That Ordinance No. 2012-18 the annual operating budget for 2013 is hereby amended; and

Section 2. That the sum of \$49,457.66 (2010 funds) is hereby appropriated into the (SHSGP) HomeLand Grant Budget, Fund #1, Department 7600, Line Item #86 – Special Projects.

The Arkansas Department of Emergency Management (ADEM), as the State Administrative Agency (SAA), recently identified additional funds through the Department of Homeland Security (DHS) FY10 Homeland Security Grant Program (HSGP) [CFDA #97.067]. Within this program, funds were identified in the State Homeland Security Program (SHSP) and the Law Enforcement Terrorism Prevention Activities (LETPA).
