ORDINANCE NO. 2013-20

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:

AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2012-18, THE ANNUAL OPERATING BUDGET FOR 2013, TO INCREASE THE PROJECTED REVENUE BY \$10,727.62, AND APPROPRIATE SAID AMOUNT INTO THE ELECTION COMMISSION BUDGET #5600.

WHEREAS: The Election Coordinator has received a grant in the amount of \$10,727.62 from the Secretary of State for the purchase of voting systems equipment; and

WHEREAS: There is now an urgent need and necessity to appropriate these funds in order to purchase the equipment.

THEREFORE BE IT ORDAINED

Section 1. That Ordinance No. 2012-18, the annual operating budget for 2013 is hereby amended; and

Section 2. That the sum of \$10,727.62 is hereby appropriated into the Election Commission's Budget #5600.

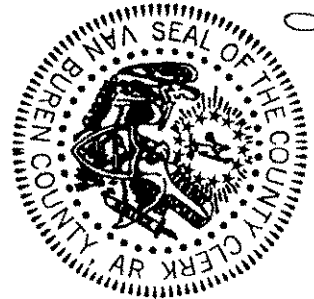
