BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:

AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2013-21, THE ANNUAL OPERATING BUDGET FOR 2014, TO INCREASE THE PROJECTED REVENUE BY \$154,500.00 IN ORDER TO APPROPRIATE SAID AMOUNT INTO THE GIF GRANTS 2014 BUDGET FUND #3506.

WHEREAS: Van Buren County has received GIF Grant Funds totaling \$89,000.00; and

WHEREAS: The County anticipates receiving an additional \$65,500.00; and

WHEREAS: There is need and necessity to appropriate these funds, in order to disburse to the various designated departments per the attached listing.

Section 1. That Ordinance No. 2013-21, the annual operating budget for 2014 is hereby amended; and

Section 2. That the sum of \$154,500.00 is hereby appropriated into the GIF Grants Budget Fund #3506 to be disbursed.

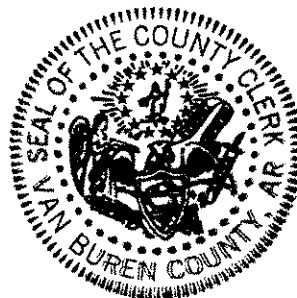
