**VAN BUREN COUNTY QUORUM COURT**

**ORDINANCE NO. 2014-12**

**BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:**

**AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2013-21, THE ANNUAL OPERATING BUDGET FOR 2014; TO INCREASE THE PROJECTED REVENUE AND APPROPRIATE \$25,000.00 INTO THE GENERAL FUND #1000, LINE ITEM 9999 AND \$100,000.00 INTO THE RADIO TOWER FUND #4800, DEPARTMENT 0421, LINE ITEM 3103.**

**WHEREAS:** In the year 2013, Van Buren County received \$25,000.00 from State G.I.F. Funds for the Sheriff's Radio Tower; and

**WHEREAS:** In the year 2014, Van Buren County has received \$25,000.00 from State G.I.F. funds for the Sheriff's Radio Tower. (These funds were appropriated into the G.I.F Fund 3506); and

**WHEREAS;** In the year 2014, the Radio Tower Fund received \$29,865.94 from State G.I.F. funds (and insurance claim payment and a donation); and

**WHEREAS:** The Sheriff's Radio Tower Fund anticipates receiving \$20,134.06 from FEMA .

**THEREFORE BE IT ORDAINED**

**Section 1.** That Ordinance No. 2013-21, the annual operating budget for 2014 is hereby amended; and

**Section 2.** That the sum of \$25,000.00 be appropriated into the General Fund #1000.


**Section 3.** That the sum of \$100,000.00 be appropriated into the Radio Tower Fund #4800.
