**BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN,
STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:**

**AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL
APPROPRIATION ORDINANCE #2013-21, THE ANNUAL OPERATING
BUDGET FOR 2014, IN ORDER TO INCREASE THE PROJECTED
REVENUE BY \$15,378.84; AND APPROPRIATE SAID AMOUNT INTO
THE VOTING SYSTEMS GRANT FUND #3038, DEPARTMENT 0199.**

WHEREAS: Van Buren County has been granted an award in the amount of \$15,378.84 for the Voting Systems Grant Fund; and

WHEREAS: These funds may only be spent on approved items and must be expended within one year of receipt of the funds; and

WHEREAS: There is now a need to appropriate the \$15,378.84.

THEREFORE, BE IT ORDAINED:

Section 1. That Ordinance No. 2013-21 the annual operating budget for 2014 is hereby amended; and

Section 2. That Fund #3038 – Voting Systems Grant Fund be created and the sum of \$15,378.84 be appropriated into the Voting Systems Grant Fund #3038 – Department 0199; Line Item 86 – Special Projects; and
