AN APPROPRIATION ORDINANCE TO AMEND APPROPRIATION ORDINANCES NO, 2014-14 AND 2014-15.

WHEREAS: Appropriation Ordinances No. 2014-14 and 2014-15 were approved for Fund No. 3038 and Fund No. 3103; and

WHEREAS: These funds were not the correct funds for these appropriations; and

WHEREAS: There is now a need to appropriate the funds into the correct Budget Fund and to void the Funds for which they were appropriated.

THEREFORE BE IT ORDAINED

Section 1. That Fund No. 3038 and Fund No. 3103 are each hereby voided.

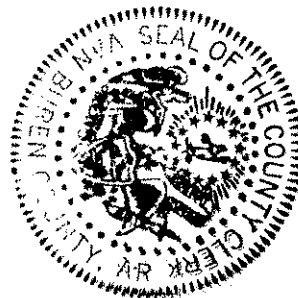
Section 2. That \$15,378.84 (Voting Systems Fund) for Ordinance No. 2014-14 is hereby appropriated into General Fund #1000.

AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2013-21, THE ANNUAL OPERATING BUDGET FOR 2014, IN ORDER TO INCREASE THE PROJECTED REVENUE BY \$15,378.84; AND APPROPRIATE SAID AMOUNT INTO THE VOTING SYSTEMS GRANT FUND #3038, DEPARTMENT 0199.

WHEREAS: Van Buren County has been granted an award in the amount of \$15,378.84 for the Voting Systems Grant Fund; and

WHEREAS: These funds may only be spent on approved items and must be expended within one year of receipt of the funds; and

WHEREAS: There is now a need to appropriate the \$15,378.84.

THEREFORE, BE IT ORDAINED:

Section 1. That Ordinance No. 2013-21 the annual operating budget for 2014 is hereby amended; and

Section 2. That Fund #3038 – Voting Systems Grant Fund be created and the sum of \$15,378.84 be appropriated into the Voting Systems Grant Fund #3038 – Department 0199; Line Item 86 – Special Projects; and

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:

AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2013-21, THE ANNUAL OPERATING BUDGET FOR 2014 TO INCREASE THE PROJECTED REVENUE BY \$28,000.00, AND APPROPRIATE SAID AMOUNT INTO THE 911 PUBLIC SAFETY ANSWERING POINTS BUDGET FUND 3103; DEPARTMENT 503; LINE-ITEM 4004 MACHINERY AND EQUIPMENT.

WHEREAS: Act 442 of 2013 provided for funding to go to "Arkansas counties for 911 public safety answering points"; and

WHEREAS: These funds are to be used solely in support of the PSAP's with our State; and

WHEREAS: The County has received these funds and there is now a need and necessity to appropriate the \$28,000.00 in order to expend them.

THEREFORE BE IT ORDAINED

Section 1. That Ordinance No. 2013-21, the annual operating budget for 2014 is hereby amended; and

Section 2. That the sum of \$28,000.00 is hereby appropriated into the 911 Public Safety Answering Points Budget Fund #3103, Department 503; Line-Item 4004 – Machinery and Equipment.
