BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN,  
STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:

AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL  
APPROPRIATION ORDINANCE #2017-39, THE ANNUAL OPERATING  
BUDGET FOR 2018, TO INCREASE THE PROJECTED REVENUE AND  
APPROPRIATE ~~\$60,000.00~~ INTO THE COUNTY ATTORNEY'S  
DEPARTMENT #1000-0430-3005 - SPECIAL LEGAL.

WHEREAS: A line item for funding a County Attorney's Department has been created by separate ordinance to administer payment of legal costs incurred in pending civil litigation filed by SWN Production Company (Arkansas), LLC, Van Buren County Circuit Court Case No. 71CV-17-251; and

WHEREAS: There is a need to appropriate money into the line item to pay for anticipated legal costs in 2018; and

WHEREAS: the above referenced matter concerns the assessment and collection of ad valorem taxes and all attorney's fees incurred therefore are subject to reimbursement by all municipalities, school districts and other local taxing units receiving ad valorem or other tax funds collected by the County Collector pursuant Arkansas Code Annotated § 16-21-114(f).

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT: ~~\$60,000.00~~ be appropriated into the County General #1000-430-3005 - Special Legal. *290000*
