WHEREAS, there is a need for the Van Buren County Office of Emergency Services and  
the Office of Emergency Management of our surrounding counties to cooperate for more  
efficient emergency and disaster response capabilities, and

WHEREAS, the Van Buren County Office of Emergency Service in the absence of a  
Mutual Aid Agreement has no authority or jurisdiction outside of their county, and

WHEREAS, The Office of Emergency Services of other counties in the absence of a  
Mutual Aid Agreement has no authority or jurisdiction outside of their county.

**THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF VAN  
BUREN COUNTY THAT:**

The Van Buren County Office of Emergency Services be authorized to enter into  
Mutual Aid Agreements with consenting surrounding counties, to permit Van Buren County  
Office of Emergency Services to call for the assistance of a participating county. Office of  
Emergency Services from a participating county to call for assistance from the Van Buren  
County Office of Emergency Services following terms and conditions.

FIRST, The Van Buren County Quorum Court has passed a resolution approving  
the terms of this agreement and authorizing the Van Buren County Judge and the Van  
Buren County Office of Emergency Services Director to sign a mutual Aid Agreement.

SECOND, The County Quorum Court of the other county has passed a resolution  
approving the terms of this agreement authorizing the County Judge and the Office of  
Emergency Services Director to sign a Mutual Aid Agreement.

THIRD, The Van Buren County Judge, Van Buren County Office of Emergency  
Services Director, and the Van Buren County Quorum Court do hereby acknowledge that  
the Van Buren County Office of Emergency Services Director has the permission to  
respond to a participating county, upon request.





WHEREAS, the Chimes Community has presented plans to renovate the Chimes Community Center building; and


