A RESOLUTION AUTHORIZING THE COUNTY JUDGE OF VAN BUREN COUNTY TO APPLY FOR A GRANT ON BEHALF OF THE DENNARD FIRE DEPARTMENT.

WHEREAS: The Van Buren County Quorum Court has determined that the Dennard Fire Department meets eligibility requirements necessary to apply for a grant under the Arkansas Rural Community Grant Programs: and

WHEREAS; The Dennard Fire Department has presented plans to purchase a Class I Rescue Vehicle: and

WHEREAS: The Quorum Court of Van Buren County recognizes the need for the purchase of a Class I Rescue Vehicle and concurs its importance and supports the Dennard Fire Department in its efforts to proceed with the same; and

WHEREAS: The Dennard Fire Department has furnished proof that they have raised \$15,000.00 through cash and/or in-kind donations to be applied to the project described herein.

Be it further resolved, that the County Judge of Van Buren County is hereby authorized to submit an application of formal request to the Arkansas Rural Development Commission for purposes of securing state grant funds in the amount of \$15,000.00 to aid and assist the Dennard Fire Department in executing the proposed project described herein and that the Treasurer of Van Buren County is further authorized to administer the grant funds for the same project.



A RESOLUTION TO AUTHORIZE A MUTUAL AID AGREEMENT
FOR THE VAN BUREN COUNTY OFFICE OF EMERGENCY
MANAGEMENT AND THE POPE COUNTY OFFICE
OF EMERGENCY MANAGEMENT

WHEREAS, there is a great need for the Van Buren County Office of Emergency Management (OEM) and the Pope County Office of Emergency Management (OEM) to cooperate together for better and more efficient emergency and disaster response capabilities for the two counties; and

WHEREAS, both the Pope County OEM and the Van Buren County OEM in the absence of a mutual aid agreement has no authority or jurisdiction outside their county; and

WHEREAS, life and property can be saved by this agreement:

NOW THEREFORE, this agreement is entered into by the Pope County OEM and the Van Buren County Office of Emergency Management. It is to permit calling for the assistance of the other in emergency and disaster response operations on the following terms and conditions.


FIRST, each Quorum Court has passed a Resolution approving the terms of this agreement and authorizing the respective County Judge and County OEM Director to sign this agreement.


