WHEREAS: Such a holiday would provide immediate financial and tax relief for consumers who make purchases of necessary goods and other tangible personal property during the sales tax holiday period; and

WHEREAS: The sales tax is generally viewed as a more regressive form of taxation that has a greater impact on lower income citizens of the state who do not traditionally benefit from other forms of tax relief such as reductions in property taxes; and


