**BE IT RESOLVED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN,
STATE OF ARKANSAS, A RESOLUTION TO BE ENTITLED:**

**A RESOLUTION TO AUTHORIZE THE COUNTY JUDGE OF VAN
BUREN COUNTY TO APPLY FOR A GRANT ON BEHALF OF THE
VAN BUREN COUNTY FAIR ASSOCIATION.**

WHEREAS: The Van Buren County Quorum Court has determined that the Van Buren County Fair Association meets eligibility requirements necessary to apply for a grant under the County Fair Building Grant; and

WHEREAS: The Van Buren County Fair Association has presented plans to apply a Cool Seal coating to the Quonset Building at the Fairgrounds to prevent further leaking; and

WHEREAS: The Quorum Court of Van Buren County recognizes the need for the project, concurs its importance, and supports the Van Buren County Fair Association in its efforts to proceed with the same; and

WHEREAS: The Van Buren County Fair Association has furnished proof that they have raised \$3,500.00 through community cash and in-kind donations to be applied to the project as a local match.

**THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF VAN BUREN
COUNTY THAT:**

The County Judge of Van Buren County is hereby authorized to submit an application of formal request to the Arkansas Rural Development Commission for purposes of securing state grant funds in the amount of \$3,500.00 to aid and assist the Van Buren County Fair Association in executing the proposed project described herein and that the County Judge and County Clerk of Van Buren County are further authorized to administer the grants funds for the same project.
