#### A RESOLUTION OF THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS, IN THE MATTER OF THE COUNTY ACCEPTING A PORTION OF STATE HIGHWAYS 330 & 336 OWNED BY THE ARKANSAS STATE HIGHWAY COMMISSION.

**WHEREAS:** There comes for consideration the matter of the County accepting a portion of roadway owned by the Arkansas State Highway Commission.

**WHEREAS:** Pursuant to Arkansas Code Annotated 27-65-109 and pending approval from the Commission, the following changes to the Van Buren County Road System, as reflected in the attached Exhibit A are hereby authorized in Van Buren County.


- The portion of Highway 330, Section 1 beginning at the junction with Highway 65 and continuing east to the end of the section and portion of Highway 336, Section 1 beginning at Highway 65 and continuing east to the end of the section, shall be transferred from the Commission to Van Buren County.
- Van Buren County's agreement to accept all responsibility, including ownership for the above described State Highways is contingent upon the Arkansas State Highway and Transportation Department's completion of resurfacing these highways, which is scheduled for mid-2014.
- By action of the Court Order, the Arkansas State Highway and Transportation Department will proceed with non-reimbursable utility relocation at no cost to the Bee Branch and Dennard Water Associations for the Highway 65 widening projects as defined in Exhibit B.

**WHEREAS:** Acceptance of the proposed changes and transfer is practical and will be in the best interest of Van Buren County and the citizens of the State of Arkansas.


