BE IT RESOLVED BY THE QUORUM COURT OF THE COUNTRY O

A RESOLUTION AUTHORIZING AND APPROVING THE EXECUTION OF A LEASE AGREEMENT WITH CATERPILLAR FINANCIAL SERVICES CORP IN ORDER TO LEASE FIVE (5) GRADERS FOR A PERIOD OF THIRTY-SIX MONTHS.

WHEREAS: The laws of the State of Arkansas (the State") authorize the County of Van Buren, a duly organized political subdivision, of the State of Arkansas, to lease personal property for the benefit of the Government Entity and its inhabitants and to enter into any necessary contracts; and

WHEREAS: The Governmental entity wants to lease equipment from Caterpillar Financial Services Corporation, an authorized Caterpillar dealer by entering into a Lease Agreement with CAT. (the form of the Agreement is hereby attached)

THEREFORE BE IT RESOLVED, (i) that the Agreement, including schedules and exhibits, is approved in substantially the form presented at this meeting, with any approved changes (as defined below). (ii) the Governmental Entity enters into the Agreement with Caterpillar and (iii) the Agreement is adopted as a binding obligation of the Governmental Entity; and

THAT Roger W. Hooper, Van Buren County Judge, and Kim Hunley, Van Buren County Treasurer are the incumbent officers of the Governmental Entity; and each is authorized, directed and empowered, on behalf of the Governmental Entity, to (i) sign and deliver to Caterpillar, and its successors and assigns the agreement and any related documents, and (ii) take or cause to be taken all actions he/she deems necessary or advisable to acquire the Equipment, including the signing and delivery of the Agreement and related documents; and

**THAT** the County Clerk of the Governmental Entity is authorized to attest to these resolutions and affix the seal of the Governmental Entity to the Agreement, these resolutions and any related documents; and

THAT nothing in these resolutions, the Agreement or any other document imposes a pecuniary liability or charge upon the general credit of the Governmental Entitly or against its taxing power, except to the extent that the payments payable under the Agreement are special limited obligations of the Government Entity as provided in the Agreement; and

THAT a breach of these resolutions, the Agreement or any related document will not impose any pecuniary liability upon the Governmental Entity or any charge upon its general credit or against its taxing power, except to the extent that the payments payable under the Agreement are special limited obligations of the Governmental Entity as provided in the Agreement; and

THAT the authority granted by these resolutions will apply equally and with the same effect to the successors in the offices of the Authorized Persons.
