RESOLUTION NO. 2018-01

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, A RESOLUTION TO BE ENTITLED:

**A RESOLUTION TO SET FORTH REQUIREMENTS FOR CAMPAIGN SIGNS AND MATERIALS, AND FOR OTHER PURPOSES;**

**WHEREAS:** the use of certain signs in the County has made it apparent that the Quorum Court wants to clarify the recently approved House Bill 1207, to amend requirements for campaign signs and materials; and

**WHEREAS:** the Quorum Court desires to provide clarification on the use of signs within the County; and

**WHEREAS:** the Quorum Court recognizes this situation needs to be rectified.

**NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:**

**SECTION 1:** In accordance with Bill 1207 Section 1 (43) (A) Printed Campaign Materials Means; (i) Literature mailed to an elector that is intended to or calculated to influence the vote of an elector in an election in this state, including without limitation signs, banners, flyer, and pamphlets; and

**SECTION 2:** (ii) Yard signs and push cards intended to or calculated to influence the vote of an elector in an election in this state. (B) Printed campaign materials does not mean political paraphernalia, including without limitation stickers, buttons, pens, T-shirts, nail files, or other similar trinkets.

**SECTION 3:** Arkansas Code 7-6-228, concerning campaign signs and materials, is amended to add an additional subsection to read as follows: (C) (1) campaign signs, campaign literature, and other printed campaign materials under this section shall clearly contain the words **"Paid For By"** followed by the name of the candidate, committee, or person who paid for the campaign sign, campaign literature, or other printed campaign materials. (2) subdivision (C) (1) of this section applies only to campaign signs, campaign literature, and other printed campaign materials created by or sponsored by a political candidate or the campaign of a political candidate.

**SECTION 4: TEMPORARY LANGUAGE. DO NOT CODIFY.** Applicability. A candidate running for reelection to the same office he or she currently holds who possesses or creates a campaign sign, campaign literature, or other printed campaign material that does not comply with this act is exempt from compliance with this act if the campaign sign, campaign literature, or other printed campaign material was created before the effective date of this act (03/31/2017).


**NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:**

**SECTION 5:** The Quorum Court has determined that we enforce House Bill 1207 and that all running for office in this County meet all standards of this bill, given the uncertainty over the use of certain signs, material, and other matters in accordance with House Bill 1207.
